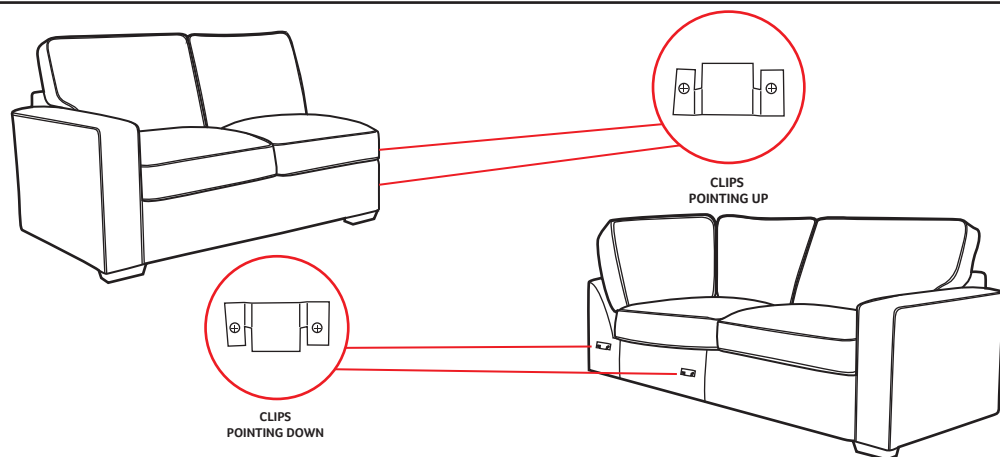
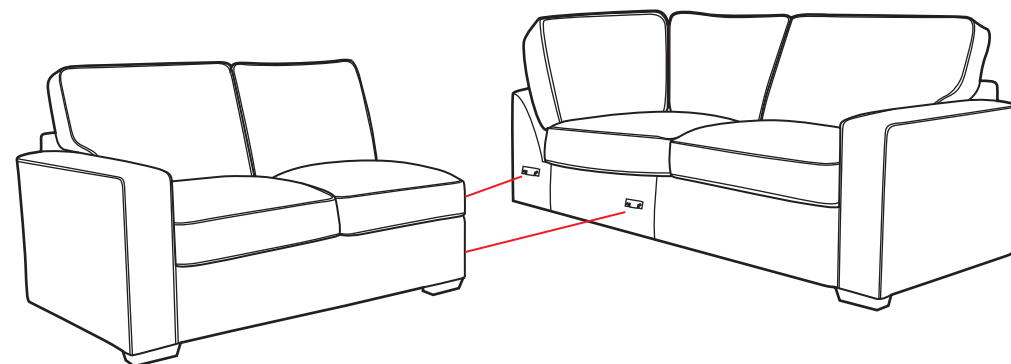


# MODULAR CLIPPING INSTRUCTIONS

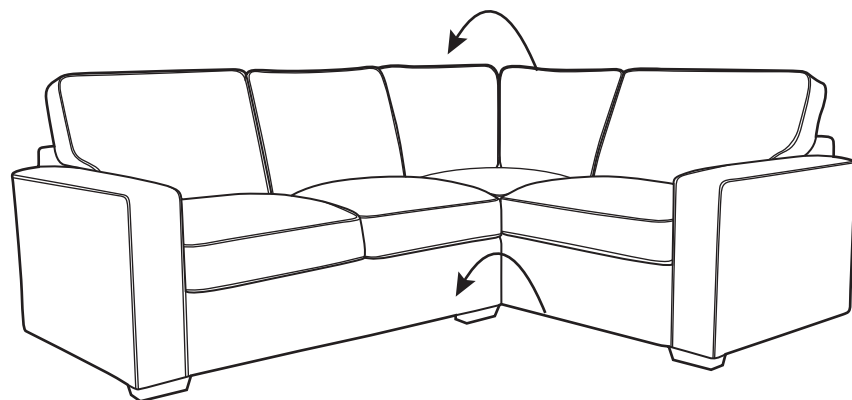
**FURNITURE IS HEAVY, MOVING OR LIFTING  
SHOULD NOT BE ATTEMPTED ON YOUR OWN**



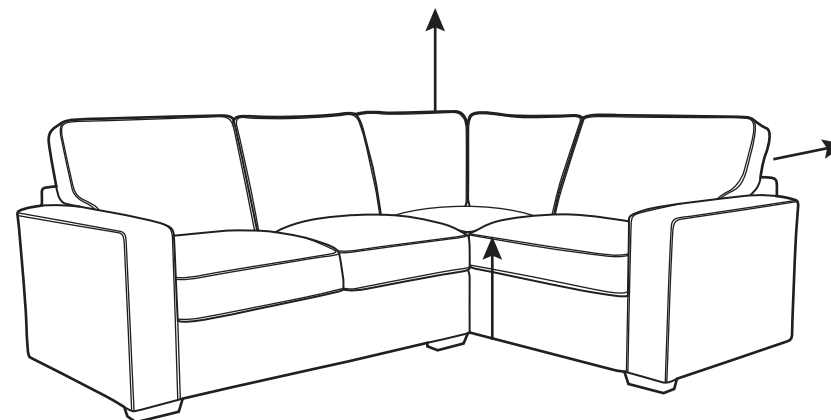
1. THERE ARE 2 SETS OF CLIPS ON YOUR MODULAR UNITS: CLIPS POINTING UP ARE ON LEFT HAND UNITS AND CLIPS POINTING ARE ON RIGHT HAND UNITS.



2. LINE UP CORRESPONDING UPWARDS AND DOWNWARDS POINTING CLIPS BY PUSHING UNITS CLOSE TOGETHER.



3. LIFT RIGHT-HAND UNIT AND SLOT DOWNWARDS CLIPS INTO UPWARDS CLIPS ON LEFT-HAND UNIT. ALL FEET MUST BE LEVEL ON THE FLOOR.



4. TO UNCLIP UNITS, GENTLY LIFT THE RIGHT-HAND UNIT OUT OF THE LEFT-HAND CLIPS. DO NOT FORCE APART WITHOUT LIFTING.

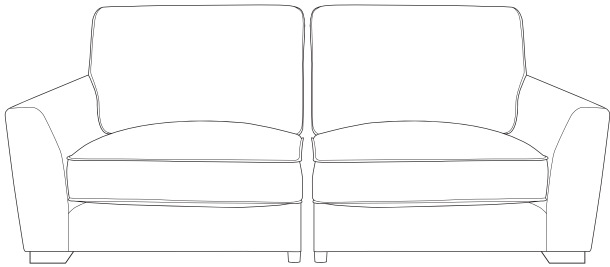
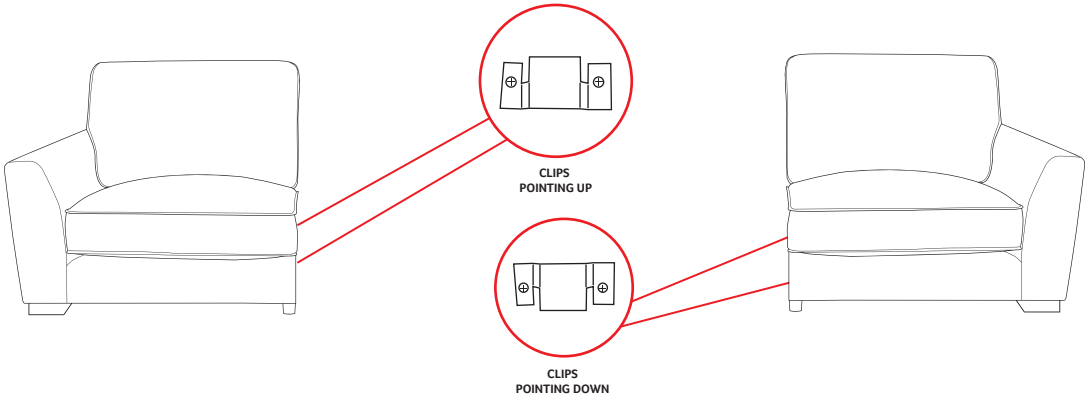
5. FOR CORNER GROUPS CONSISTING OF 3 UNITS OR MORE PLEASE REPEAT STEP 1-3. CLIPS FACING UP WILL ALWAYS BE ON THE RIGHT SIDE OF THE UNIT AND CLIPS FACING DOWN WILL ALWAYS BE ON THE LEFT SIDE OF THE UNIT.

PLEASE NOTE IF YOU HAVE A WOODEN OR LAMINATE FLOOR, WE WOULD ADVISE YOU TO TAKE STEPS TO PROTECT YOUR FLOOR FROM POTENTIAL SCRATCHES AND MARKS. THE EASIEST WAY IS TO SOURCE PROTECTIVE PADS AND PLACE UNDER THE FEET OF YOUR UPHOLSTERED FURNITURE TO PREVENT MARKS BEING MADE OR PLACE THE UPHOLSTERED FURNITURE ON TOP OF A PROTECTIVE COVER. THE MANUFACTURER CANNOT BE HELD RESPONSIBLE FOR DAMAGE SUBSEQUENTLY CAUSED TO YOUR FLOORING BY NOT TAKING THE PREVENTIVE MEASURES.

# 4 SEATER MODULAR CLIPPING INSTRUCTIONS

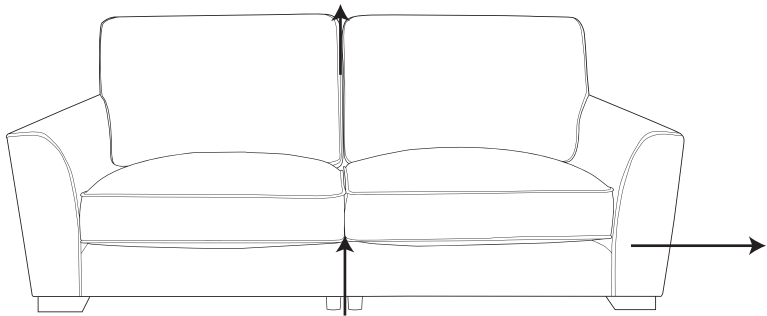
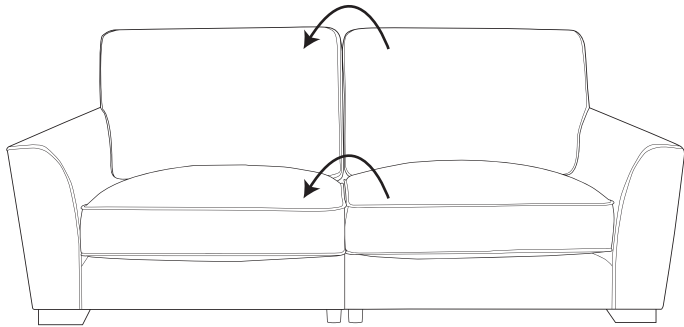
\*Clipping instructions only. For feet please refer to the accompanying foot fitting instructions / travel glide removal.

1. THERE ARE 2 SETS OF CLIPS ON YOUR MODULAR UNITS: CLIPS POINTING UP ARE ON LEFT-HAND UNITS AND CLIPS POINTING DOWN ARE ON RIGHT-HAND UNITS

2. LINE UP CORRESPONDING UPWARDS AND DOWNWARDS POINTING CLIPS BY PUSHING UNITS CLOSE TOGETHER.



3. LIFT RIGHT-HAND UNIT AND SLOT DOWNWARDS CLIPS INTO UPWARDS CLIPS ON LEFT-HAND UNIT. ALL FEET MUST BE LEVEL ON THE FLOOR.

4. TO UNCLIP UNITS, GENTLY LIFT THE RIGHT-HAND UNIT OUT OF THE LEFT-HAND CLIPS. DO NOT FORCE APART WITHOUT LIFTING.
